

## **MEMORANDUM OF AGREEMENT**



between

國立屏東大學 National Pingtung University

## Rambhai Barni Rajabhat University, Kingdom of Thailand (hereinafter referred to as Party A)

and

National Pingtung University, Republic of China (Taiwan) (hereinafter referred to as Party B)

for the Collaboration of the International Schweitzer Program 2022 sponsored by the Ministry of Education, Republic of China (Taiwan)

- i. In order to cultivate student teachers to become future teachers with an international vision, and to strengthen the international literacy of student teachers, enhance their cultural understanding, humanistic care, international experience and cultivate language ability, encourage student teachers to learn new knowledge and enhance their willingness to teach in foreign schools such as senior secondary schools, kindergartens, overseas Taiwan schools and Taiwan business schools in mainland China (hereinafter referred to as foreign schools), and encourage the practice of the spirit of international Schweitzer caring for the vulnerable and professional service, so as to give play to the great love of education and promote the exchange of education between universities and foreign schools for teacher training.
- ii. In order to promote exchanges between the two sides, Party B will recommend outstanding student teachers to Party A for the International Schweitzer Program as necessary, so as to strengthen the professionalism and international outlook of student teachers between two universities.
- iii. Party B students who go to Party A to implement the International Schweitzer Program shall comply with Party A's regulations and accept Party A's arrangements and guidance, and Party A and Party B shall jointly discuss the details, educational service items and connotations of the International Schweitzer Program.

- When Party A accepts Party B to Party A for the International Schweitzer iv. Program, Party A will be able to provide relevant educational advice and counseling for Party B's student teachers in a timely manner.
- Party B shall not be less than two weeks during party A's actual ٧. implementation of the International Schweitzer Program.
- The validity period of this cooperation contract shall be one year since the vi. date of signing and according to the needs of both parties, the contract shall be renewed one month before the termination of the contract.
- vii. After the above-mentioned cooperation contract has been entered into force by mutual agreement between A and B, both parties shall be bound by this contract, and if one party does not perform in accordance with this contract, another party may terminate this contract.
- viii. The unfinished matters of this cooperation contract may be added or subtracted according to actual needs, and shall be implemented with the consent of both parties.
- This cooperation contract shall be made in duplicate, and each party shall ix. hold one copy as the basis of reference.
